It is 70 years since the enactment of Bunreacht na hÉireann. The Law School in Trinity College is marking this event with a conference addressing a number of contemporary issues in Irish constitutional law and constitutional theory. A wide range of national and international speakers will address many constitutional doctrines, including the following: the family, property rights, equality and dignity, religion, and the rules of evidence. In addition, speakers will address the appropriate method of interpreting the Constitution, the philosophical and historical influences on the Constitution, as well as the likely impact of the European Convention on Human Rights Act 2003.

This conference will be of interest to all practising and academic lawyers, as well as people in public service and academics in related disciplines such as history, political science and philosophy.
